The schools will provide a meeting space for the social worker and the student.
- E. Approve resolution authorizing and directing an abatement of a portion of taxes levied on certain property located in the Whiteside Carroll Enterprise Zone. The River Bend CUSD #2 School District participated in the previous Whiteside Carroll County Enterprise Zone that expired on December 31, 2017. The state granted the Whiteside Carroll Enterprise Zone, through application, a new zone that went into effect on January 1, 2018 through December 31, 2032.
